2011 Changes to the Colorado Child Care Contribution Credit

Due to a recent change in state law, the Colorado Child Care Contribution Tax Credit will be deferred (but not eliminated) for all gifts made in calendar year 2011. Donors who make gifts to the Mile High United Way Child Care Fund and other eligible child care contributions funds and agencies during 2011 will not be able to claim the credit on their tax return until it is reinstated. The availability of the credit in calendar year 2012 will be announced by the Colorado Legislative Council at the

end of December 2011. The credit will be available starting again in 2013 in a limited fashion: in calendar years 2013 and 2014, the amount of the credit that can be claimed will be 50% and 75% respectively. In 2015, the credit will returned to its original form. With your donation to Mile High United Way, you can take advantage of tax credit programs that enable you to give more, receive something in return and possibly multiply your gift in the process.

When you give a minimum gift of \$500 by check or credit card to an eligible Mile High United Way agency or project, you will receive either a 25% or 50% tax credit from the State of Colorado.

Denver Enterprise Zone (DEZ)

Help increase the economic viability of individuals and families in metro Denver through the Denver Enterprise Zone. Direct your gift to a Denver Enterprise Zone (DEZ) project or agency, and you will be eligible for a 25% tax credit when you file your state income tax return. For example, for a minimum gift of \$500, you would receive a \$125 tax credit from the State. Your DEZ gift supports programs and

services included in our Adult Self-Sufficiency Initiative. (Donors may give gifts of stock to the DEZ, but the tax credit may vary.) If giving a gift of stock to the Enterprise Zone, please contact your donor relations representative at 303-433-8383.

Child Care Contribution Credit (CCCC)

Help increase the quality and availability of child care in metro Denver through the Colorado Child Care Contribution Credit (CCCC). You will be eligible for a 50% tax credit when you file your Colorado income tax return. Your minimum gift of \$500 may net you a \$250 tax credit from the State. CCCC supports the School Readiness Initiative by providing quality early childhood education and after-school opportunities for metro Denver's children and youth. (In-kind gifts, such as stock, cannot be used for the Colorado Child Care Contribution Credit.)

Here's an even greater option. Direct your gift to Mile High United Way's Child Care Fund, Lights On After School program or the School Readiness Initiative, and receive a 50% tax credit. Your gift may also be matched with Federal matching funds through the Child Care and Development Fund which will bring added dollars into Colorado. Your minimum gift of \$500 means a \$250 tax credit for you and \$1,000 worth of quality child care in metro Denver and the State of Colorado.

Benefits to You

• Considerable tax savings.

- Both individuals and corporations can take advantage of tax credits.
- Excess tax credits may be carried forward for up to five years.

Guidelines

- · Payroll deduction does not apply.
- Tax credit donations must be a minimum of \$500.
- Donations may be made by check or credit card. All donations should include a pledge form showing DEZ or CCCC agency/program selection.
